The appointments of the above candidates as Junior Assistants in Power Development Department shall be subject to the following conditions:-

1. They shall report to Development Commissioner (Power) within a period of 21 days from the date of issue of appointment order. In case of failure of any appointee to join within the stipulated time period, his/her appointment shall be deemed to have been cancelled without any further notice.
2. The appointee shall be allowed to join only on production of the following certificates in original:-
 - i. Academic Qualification Certificates.
 - ii. Technical Qualification Certificates.
 - iii. Matriculation/Date of birth certificates.
 - iv. Health Certificate from the concerned Chief Medical Officer of the District.
 - v. Permanent Resident Certificate issued by the Competent Authority.
 - vi. Certificates from the concerned District Industries Centre (DIC) and District Employment & Counselling Centre to the effect that no loan under self employment scheme has been taken by the appointee.
 - vii. Relevant category certificates.
3. The appointment of above candidates as Junior Assistants in Power Development Department shall further be subject to the conditions that:-
 - (i) Each appointee shall submit an affidavit at the time of joining undertaking therein that in case any adverse report about his/her Character and Antecedents is received from the office of the IGP, CID, J&K, to whom a reference shall be made by the Development Commissioner, Power, the candidate shall have no right to claim his/her appointment as Junior Assistant (Electric) in the Power Development Department and his/her appointment as such shall be deemed to have been cancelled *ab-initio*;
 - (ii) Verification/genuineness of the qualification/technical/reserved certificates and others certificates from the concerned issuing authorities.

4. The salary of the appointees shall be drawn and disbursed only if satisfactory reports in respect of (i) and (ii) above are received in their favour.

5. The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO 400 dated 24.12.2009 and the appointees shall be on probation for a period of 2 years.
6. The inter-se-seniority of these appointees shall be determined in accordance with the merit acquired during selection and in terms of Jammu and Kashmir Civil Service (Classification, Control and Appeal) Rules, 1959 and other relevant rules.

The above appointments shall be further subject to the outcome of Writ Petition(s), if any, pending before any Competent Court of Law.
