- 3) Date of Birth Certificate
- 4) Certificate of Permanent Residence.
- 5) Non-Loan Certificate under Self Employment Scheme from DIC and Employment Department.
- 6) Character and Antecedents Certificate from CID. Moreover, Development Commissioner (Power) shall not draw and disburse the salary of the appointee until satisfactory report is received from CID.
- 7) If on verification, the certificates produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio.
- 8) Any other certificate required under rules with particular reference to SRO-43 of 1994.
