Sanction is hereby accorded to the temporary appointment of Mr. Rayees Ahmad Khan S/o Late Mr. Mohd Amin Khan (Ex-Lineman) R/o Gundchabotra (Moshnair) Tehsil Handwara, District Kupwara as Class-IV, in the Pay Scale of Rs. 4440-7440 with the Grade Pay of Rs. 1300/- in Power Development Department in relaxation of prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The appointee shall report to the office of the Development Commissioner (Power) within 21 days. The Development Commissioner (Power) shall allow the candidate to join only on production and verification of following certificates in original:-

- 1) Academic Qualification Certificate
- 2) Age/Health Certificate
- 3) Date of Birth Certificate
- 4) Certificate of Permanent Residence.
- 5) Non-Loan Certificate under Self Employment Scheme from DIC and Employment Department.
- 6) Character and Antecedents Certificate from CID. Moreover, Development Commissioner (Power) shall not draw and disburse the salary of the appointee until satisfactory report is received from CID.
- 7) Any other certificate required under rules with particular reference to SRO-43 of 1994.

If on verification, the certificates produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio.
