Subject:- Approval to the enhancement in some components of the Rehabilitation and Resettlement Plan for the Project Affected Families of the Kishanganga HEP.

In partial modification of Government Order No.234-PDD of 2015 dated 09.12.2015, sanction is hereby accorded to the:-

1. Enhancement of the provision of plot for house site from 10 Marla to 1 kanal, per fully displaced PAF;
2. Enhancement of the provision for construction of house from Rs. 7 Lakh to Rs.12 Lakh, per fully displaced PAF;
3. Recalculation of the 50% additional amount to be paid to the fully displaced PAFs who opt for cash in lieu of plot and house in the resettlement colony accordingly;
4. Consequent enhancement in the ceiling of the overall R&R package from Rs.152.72 Crores to Rs.171.22 Crores.

Sanction is also accorded to the adoption of the basis/criteria of R&R approved for the PAFs of Kishanganga HEP in the draft R&R policies to be prepared by the Relief and Rehabilitation Department. The draft policies may be placed by the Relief and Rehabilitation Department before the Cabinet expeditiously.
