Sanction is hereby accorded to the temporary appointment of Mr. Tohefiq Ahmed S/o Late Sh. Abdul Rashid Bakerwal (Ex-Class-IV) R/o Maitra Govind Pora Tehsil & District Ramban, as Class-IV, in the Pay Band of Rs. 4440-7440 with the Grade Pay of Rs. 1300/- in Electric Division Batote, in relaxation of prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The appointee shall report to the office of the Development Commissioner (Power), J&K Jammu within 21 days from the date of issue of this order. The Development Commissioner (Power), J&K Jammu shall allow the candidate to join only after production and verification of following certificates in original:-

- a) Academic Qualification /date of birth certificate (s);
- b) Health certificate from concerned Chief Medical Officer of the District;
- c) Permanent Resident Certificate issued by the competent authority;
- d) Certificate from the concerned District Industries Centre and District Employment and Counseling Centre to the effect that no loan/ financial assistant under self employment scheme has been availed by the appointee.
- e) Any other certificate required under rules;
- f) The appointee shall also furnish an undertaking at the time of joining to the effect that in case any adverse report about his character and antecedents is received from the IGP, CID, J&K, to whom a reference shall be made by the Chief Engineer and if any of the certificate furnished by him are found fake or forged, the appointee shall have no right to claim his appointment and same shall be deemed to have been cancelled ab-initio;
- g) The Chief Engineer shall also obtain verification/genuineness of the academic and other certificates/ documents from the concerned issuing authorities.

It is further ordered that salary of the appointee shall be drawn and disbursed only after satisfactory reports in respect of (f) and (g) above are received from the concerned quarters. His appointment shall be governed by the "New Pension Scheme" as per SRO 400 dated: 24th December, 2009.


