Subject: Final seniority list of Junior Engineers (Civil), Diploma Holders borne on the establishment of Power Development Department.

**WHEREAS**, vide Government Order No. 279-PDD of 2007 dated 24.09.2007, the final seniority list of Junior Engineers (Civil), Diploma Holders of Power Development Department was issued; and

**WHEREAS**, pursuant to issuance of the final seniority list issued vide Govt. Order No. 279-PDD of 2007 dated 24.09.2007, some objections in the seniority list were received in the Department, which were examined and accordingly a notice under endorsement No. 1577 dated 22.05.2009 was published in the press, with some changes in the final seniority list as per the seniority/date of 1<sup>st</sup> appointment of the members of the service for information of all the concerned, who were likely to be affected by intending action of the department, however, the same could not be finalized; and

**WHEREAS**, further vide Government Order No. 134-PDD of 2007 dated 06.06.2007 on the recommendations of DPC/PSC, the seniority list of five (5) Assistant Executive Engineers (Civil), Power Development Department has been issued, out of which one officer namely Sh. Shiban Ji Koul has retired after attaining the age of superannuation; and

**WHEREAS**, one of the applicant, Sh. Govind Ram, I/C AE (Civil) figuring at S. No. 30 of the final seniority list of J.Es (Civil), PDD filed a Writ Petition bearing SWP No. 2302/2014 c/w SWP No. 3036/2010-titled Govind Ram & Ors V/s State & Ors for quashing of the Govt. Order bearing No. 06-PDD of 2015 dated 06.01.2015 and making promotion after removing the

anomalies in the seniority list and considering all the eligible candidates as per the orders already passed by the Hon'ble Court; and

**WHEREAS**, the case of the petitioner Sh. Govind Ram was considered vide Government Order No. 207-PDD of 2018 dated 26.09.2018 and subsequently rejected, but the stand taken by the department was not agreed to by the Hon'ble Court; and

**WHEREAS**, the petitioner filed a Contempt Petition regarding correction of his name "Govind Ram" instead of 'Govind Ram Sharma' and date of 1<sup>st</sup> appointment as "28.02.1994" instead of 28.07.1994 and filing of compliance report before the Hon'ble High Court; and

**WHEREAS**, consequent to other Court directions and in compliance to judgment dated 21.04.2008 passed in SWP No. 559/2008, CMP No. 1018/2008-titled Altaf Ahmad Zadoo V/s State and Ors, one more applicant namely Sh. Altaf Ahmad Zadoo, Junior Engineer (Civil), PDD has also been included in the seniority list of J.Es (Civil) PDD vide Government Order No. 170-PDD of 2018 dated 24.07.2018, and assigned seniority position at serial No. 32 (below the name of Sh. Ishfaq Rasool Bhat (seniority No. 31) amongst the Junior Engineers (Civil) appointed on the same date i.e. 28.07.1994 vide Govt. Order No. 279-PDD of 2007 dated 24.09.2007; and

**WHEREAS**, the names of three Junior Engineers (Civil) namely Sh. Vinod Kumar Verma, Sh. Shiv Dev Singh Jasrotia and Sh. Mohammad Shafi Dar (serial No. 14, 15 & 17 respectively) of revised tentative seniority list of J.Es (Civil), PDD needs to be deleted from the seniority list of Junior Engineers (Civil), PDD, as they have been promoted as Assistant Engineers (Civil) on the force of various Court directions from time to time; and

**WHEREAS**, vide Circular No. PDD/HRM/02/2019 dated 30.01.2019, a tentative seniority list of thirty one (31) Junior Engineers (Civil) borne on the establishment of Power Development Department was issued, and uploaded on the official website of Power Development Department for inviting objections in the matter from the members of the service within the stipulated period of time; and



**WHEREAS**, in response to this, three (3) objections were received which were examined thoroughly viz-a-viz; with reference to the records available in the HRM Branch of PDD and necessary action, wherever required, has been taken while finalizing the said Seniority list.

Now, therefore, the final Seniority list of Junior Engineers (Civil), Diploma holders, borne on the establishment of Power Development Department forming **Annexure** to this order is hereby issued as on 23.05.2019 for information of all the concerned members of the service(s) which shall be subject to the final outcome of the Writ Petition(s), if any, pending consideration before any Competent Court(s) of law.

**Note:** The date(s) of birth recorded in the seniority list shall not be taken as authentic, but shall be subject to further verification with reference to the service book and matriculation certificate of the concerned members of the service.
